Above non-agency fee includes an additional \$13 health fee and \$1 student rep. fee. Public Safety Training Center Classes only: Parking tickets are required unless you have an E-plated vehicle. Tickets may be purchased from vending machines in the parking lot for \$3 per day. Weekly permits for courses of one week or more can be purchased on the first day of class for \$3 per week. Location:	This course will be held at the Public Safety Training Center, 5743 Skylane Blvd., Windsor, CA 95492. Classroom 701. Directions to PSTC and map attached. Directions and Map with nearby lodging: PSTC Google Map . Accommodation list provided upon request.
Course Description:	This 40 hour course is designed to provide individuals with the knowledge of animal related law and enforcement. Specifically, the course will cover areas of professionalism, safe care and control of animals, as well as officer safety techniques which include the use of personal protection tools and effective communications skills. Course content includes animal law, tactical communications, handling vicious and dangerous animals, defensive tactics, and bite stick (baton) and O.C. pepper spray training. On the last day of class, a field trip will be taken to the Sonoma County Animal Shelter located at 1247 Century Court, Santa Rosa, CA 95403.

For agency-sponsored students, course enrollment takes place at the beginning the class. Students not sponsored by a public safety agency may register for this course using the normal college registration process. This may be done online or in person. Students who are not currently enrolled at Santa Rosa Junior College or who have not taken classes at the college in the last year must complete a new application for admission prior to registering.

Directions:

From the Bay Area and Santa Rosa:

Take Highway 101 north to the Shiloh Road exit in Windsor. At the light, turn left and continue over the freeway and past the railroad track to the stoplight at Skylane Blvd. Turn left on Skylane and continue to the Public Safety Training Center on the right hand side of the road.

From North of Santa Rosa:

Take Highway 101 south to the Shiloh Road exit in Windsor. At the stop sign, turn right on to Shiloh and continue past the railroad track to Skylane Blvd. Turn left on Skylane and continue to the Public Safety Training Center on the right hand side of the road.
